What methods of collection can be used?

- Direct debit
- Cheque (often to pass back a bill payment or to pay a bill, making the bill payment or to pay a bill)
- Credit card
- Debit card
- Personal Transfer
- Standing Order
- Cash (should be paid into a bank account or not used as a way to pay a bill, as the payment is not secure)

Does it matter how you collect?

When do payments have to be made?

Check the terms of the bill, they may be different to those set out for billing

Example: Billing Requirements – payments are required on 1st January each year

Collection Requirements – Quarterly payments, based on calendar quarters

Are Payment Plans Allowed?

The collection requirements are laid out in the bill. Agents & Landlords may collectively make a decision to offer payment plans regardless of these terms. This should be agreed before any bills are sent against these terms.

How do you collect the monies?

There are multiple options available and the decision could change from one client to the next

- Direct Debit First
- In line with information provided by the Landlord at time of payment
- Personal Bank First
- Service Charge before Rent
- Rent before Service Charge

Is there a system you have in place to do this automatically for you?

What happens if you receive money from a Landlord and from a Tenant?

Receiving payments from two parties can be challenging. Having clarity is often complicated over a weekly period, which is likely to be different to the service charge billing/collection requirements.

The key to this is ensuring that you provide all parties with information when the amounts due change and that you ensure that the account is receiving appropriate, regular payments before raising any reminders and issuing any arrears notices.

What happens if Landlords send one payment to cover both Service Charge and Managing Payments?

Monies should always be receipted into a Client Account in the first instance and then any element of the payment that is due to the agent should be paid from the client account and an appropriate audit trail of what this was for and why it is due should be kept.
