4. That Contestant Cody Wommack was a candidate for the At-Large Position #4 Daingerfield - Lone Star Independent School District Trustee position in the May 7, 2016 school board election; and
5. That Contestant Cody Wommack has no standing to file an election contest against Contestee Marie Skipper.
