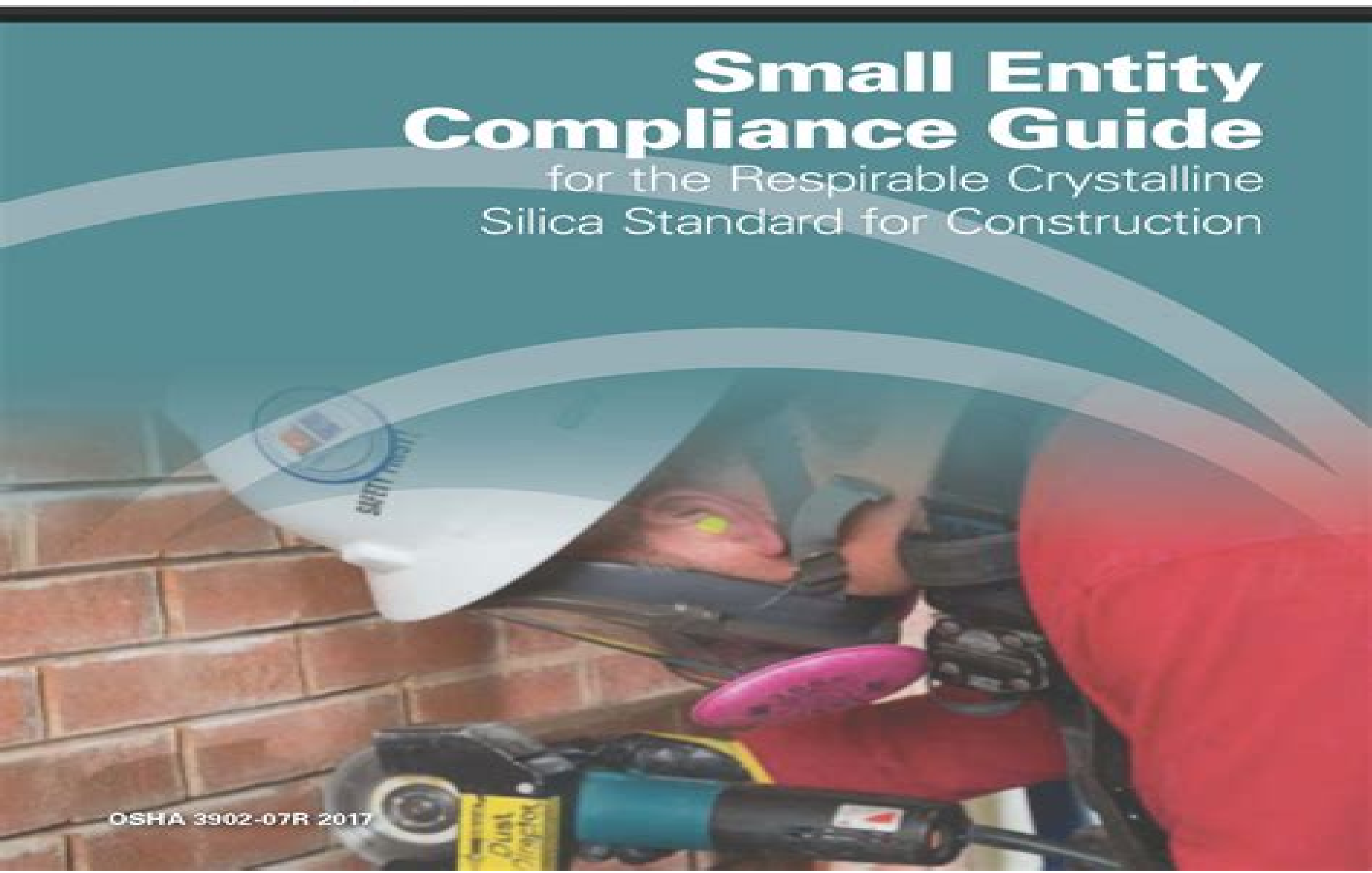

On October 5, 1998, OSHA issued a revised standard that updated and replaced that 1971 standard. The revised 1998 Respiratory Protection standard also included a new provision that allowed the development of new fit tests. In compliance with this provision, OSHA approved and adopted an additional quantitative fit testing protocol, the controlled negative pressure (CNP) REDON fit testing protocol, in 2004. In August 2006, OSHA again revised the standard by adding definitions for APF and MUC and a table of APF values. This guide provides a discussion of these APF provisions and their role in the overall Respiratory Protection standard.
