For instance: currency fluctuations, non-payment by the party, political instability, the creditworthiness of the parties, etc. Trade finance protects two parties of a transaction from these aforementioned risks. It also functions as a protection against the risks of non-payment, and non-receipt of goods, trade finance also enhances the efficiency and revenue

- Importers
- Exporters
- Bainks
- Insurers
- Credit Agencies
- Trade Finance Companies

Scope of Finance:

- Real and financial assets: Real assets are, value-driven physical assets with an intrinsic value by itself include building, land, automobile, machinery, etc. On the contrary, highly liquid assets with realized economic value include stocks, bonds, mutual funds, bank deposits.
- Equity and borrowed funds: Equity, residual claim on assets of a company after subtracting third party's claim, represents the value that would be returned to a company's shareholders.
- ☑ Finance and management functions: Finance and management function comprises planning, organizing, directing, and controlling the financial activities such as procurement and utilization of funds of the enterprise. It means applying general management principles to the financial resources of the enterprise.
